POLICY STATEMENT VEHICLE CROSSINGS

PURPOSE To establish requirements for vehicle crossings within the City.

POLICY

1. Application and Construction

- 1.1 All owners of improved private land located within the City shall have a formalised vehicle crossing constructed from a public thoroughfare to their property.
- 1.2 All vehicle crossings are to be constructed in accordance with the City's "Specifications for the Construction of Vehicle Crossings", available on the City's website www.gosnells.wa.gov.au.

2. Subsidy

- 2.1 The City will pay a maximum contribution of 50% of the cost of a standard vehicle crossing when it is constructed to the City's specifications.
- 2.2 The subsidy applies to the first standard crossing for each individual property. The total cost of construction of a second or any subsequent vehicle crossings shall be borne by the applicant.

3. Maintenance and Removal

- 3.1 The renewal and maintenance of a vehicle crossing is the responsibility of the property owner.
- 3.2 If a crossing becomes redundant, it shall be removed at the owner's cost.
- 3.3 Where the location of a new crossover requested by the property owner conflicts with existing road reserve infrastructure assets, the cost to relocate the assets will be borne by the property owner.
