Applications must be lodged at least 14 days prior to the event, or they may not be processed.

Definition:	"charitable organisation" means an institution, association, club, society or body whether incorporated or not, the objects of which are of a charitable, benevolent, religious, cultural, educational, recreational, sporting or other like nature and from which any member does not receive any pecuniary profit except where the member is an employee or the profit is an honorarium.
	"Simplified Trading Permit" means a permit that can be issued to registered mobile or temporary food business that intends to trade at an approved event within the participating local government areas (City of Gosnells, City of Canning, Town of Victoria Park)
