Description:	<p>The Welcome to Country project is located on Whadjuk Boodja, country of the Noongar people of South Western Australia.</p> <p>The Principal is seeking to appoint a Contractor to undertake construction of landscape, playground, electrical and irrigation works at Mary Carroll Park, Gosnells. The Principal is hoping to achieve a parkland inclusive of an all abilities all ages playground, that is inspired by the Mary Carroll Park Vision Plan, the natural environment and consultation with local community groups. The Welcome to Country project aims to express local Noongar culture in the landscape.</p> <p>The Contractor will be required to provide everything necessary to carry out the works required under the proposed Contract and in accordance with the scope of works. The Project is jointly funded by the City of Gosnells and Lotterywest under a funding agreement that financially expires in December 2023 and construction must be fully completed prior.</p> <p>The project seeks to create a regionally significant destination park that references Noongar culture and the natural environment. The project has been developed in consultation with the Friends of Mary Carroll Wetland group and the Langford Aboriginal Association, and both groups maintain an ongoing interest in the project. The project has been reviewed by an accredited access and inclusion consultant and the project must adhere to principles of universal design, accessibility and inclusion outcomes. The project includes some custom play items and requires specialist design and construction skills to bring to fruition.</p> <p>This contract may have to run concurrently with:</p> <ul style="list-style-type: none">• pedestrian bridges contract by others, which seeks to improve access and circulation within the park;• ablutions building works by others, which seeks to enable patrons to stay and play for longer;• revegetation wetland planting to the Causeway which seeks to improve the edges; and• carpark works by the City, which seeks to improve parking capacity and provide accessible parking. <p>A Mandatory Tender Briefing will be held at Mary Carroll Park (next to the carpark on Eudoria Street, Gosnells) on Tuesday, 31 January 2023 at 9am sharp.</p>
