Works will be issued via Purchase Order, dependent on the requirements of the Principal and as described below:</p> <p><b>Full service:</b> the Contractor will provide all labour, plant and equipment, materials, chemicals, transport/cartage, supervision/administrative costs, travelling expenses etc. for the supply, spray and cover of single coat emulsion Primer Seal and aggregate spread.</p> <p><b>Supply and Spray only</b> - the Contractor will provide chemicals, materials, spreader truck and spray truck (including operator and travel).</p> <p>It is estimated that during the contract term approximately 20,000m<sup>2</sup> of pavement will require a primer seal annually, in accordance with the City's road works program.
